Emergency Procedures

Precautions for Safe Handling

Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Avoid inhalation of vapours and mists, and skin or eye contact. Maintain high standards of personal hygiene ie. Washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatabilities

Store in a cool, dry, well-ventilated area, out of direct sunlight. Store in suitable, labelled containers. Keep containers closed when not in use. Ensure that storage conditions comply with applicable local and national regulations.

Occupational exposure limit values

Eye Protection

Not normally required. Under industrial conditions, safety glasses with side shields or chemical goggles should be worn.
